

**St. Clare School Dance (SCS) Permission and Participation Agreement**

**Admission: \$20.00 cash-only at the door**

**To be eligible to participate in the dance youth must be an active (2023-2024) school year St. Clare School participant, attend a Catholic school or be a member of a Catholic community.**

**RELEASE OF ALL CLAIMS: (INJURY RISKS, EMERGENCY MEDICAL, CODE OF CONDUCT) PARENTS OR CHILDREN WHO DO NOT WISH TO ACCEPT THE RISKS DESCRIBED IN THIS WARNING SHOULD NOT SIGN THIS Permission and Participation Agreement:** By its nature, Participation in youth activities includes risk of injury that may range in severity from minor to disabling to even death. Although serious injuries are not common in supervised youth activities, it is impossible to eliminate the risk. Participates can and have the responsibility to help reduce the chance of injury. Participant must obey all safety rules.

**I have read the above warning and release and understand its terms.** I understand that all youth activities can involve **RISK OF INJURY**, including, but not limited to, those risks outlined above. In consideration of **St. Clare School** permitting my child to participate in the youth activity I hereby agree to hold **St. Clare School** collectively and individually, its employees, agents, representatives, medical personnel and volunteers harmless from any and all liability, actions, caused or actions, debts, claims or demands of any kind and nature whatsoever that may arise by or in connection with participation of my child/ward in this youth activity. This includes all claims based on negligence. The terms hereof shall serve as a release and assumption of risk for my heirs, estate, executor, director, and assignees and for all members of my family.

**By signing this Permission and Participation Agreement**, we acknowledge that we have read the above information. "I hereby give my consent for the below named participant, 1. To participate in the youth activities described above, 2. To receive, through a medical doctor of the Program Director's choice, emergency medical care that may become reasonably necessary in the course of such youth activity. I further agree not to hold **St. Clare School** or anyone acting in its behalf responsible for any injury occurring to the below named participant in the proper course of such youth activities.

**EMERGENCY INFORMATION AND MEDICAL TREATMENT CONSENT:** In emergency, contact the parent or legal guardian as indicated on this form. I as the parent or guardian of the participant below recognize that as a result of youth activity participation, medical treatment on emergency basis may be necessary and further recognize that the Program Director may be unable to contact me for my consent for emergency medical care. I do hereby consent in advance to such emergency care, including hospital care, as may be deemed necessary under the existing circumstance.

**PUBLICATIONS:** I hereby give **St. Clare School** permission to use my child's photograph and/or name for advertising and/or newspaper purposes in promotion for **St. Clare School**

**CODE OF CONDUCT:** 1. Participant will remain inside designated dance boundaries during the dance. 2. Participant will obey the requests and instructions of any **SCS** designated adult: chaperone, dance monitor, site monitor, security person or any **SCS** person-in-charge. Failure to do so will be deemed a violation of the **Code of Conduct**. 3. Abusive language and/or actions used toward any participant or adult will not be tolerated and is cause for immediate dismissal. 4. Clothing may not have any reference to drugs, tobacco, alcohol, sex, gangs and may not be unchristian in nature. Shorts and skirts will be modest with regard to tightness and length. **NO Short shorts, NO mini skirts, NO bare midriffs and NO tank tops will be allowed.** If clothing is found to be objectionable, a call will be made to parents to either pick up the child or bring appropriate clothing. 5. There will be no inappropriate dancing or public displays of affection. 6. All dance participants are minors. Therefore, no inappropriate age-related activity will be permitted. 8. Participant will not bring any outside beverages, including personal water bottles to the dance. All bags/backpacks will be checked for outside beverages. The contents of all beverage containers will be disposed of prior to entry to the **SCS** dance. Violations may result in dismissal from future dances.

**CYBER-BULLYING/CYBER ABUSE:** Cyber-bullying and/or cyber-abuse is contrary to the **SCS** Code of Conduct. It has no place in or associated with **SCS** sponsored activities. Cyber-bullying and/or cyber-abuse is the targeted bullying of another person via technology. It includes, but is not limited to: text message bullying/abuse, picture/video clip bullying/abuse, phone call bullying/abuse via mobile phones, email bullying/abuse, chat-room bullying/abuse, bullying/abuse through Instant Messaging and bullying/abuse through websites like MySpace, Facebook, Twitter, Instagram, Snapchat and the like. Cyber-bullying and/or cyber-abuse is prohibited associated with or related to **SCS** sponsored activities. If you or any other person has been subjected to cyber-bullying and/or cyber-abuse associated with or related to a **SCS** sponsored activity, you should immediately notify **St. Clare School** (**SCS** takes such complaints seriously and investigates promptly so that appropriate corrective action can be taken.

**RESPONSIBILITY:** Parent/Guardian must stay with their child(ren) until they are checked in at the registration tables and inside the dance pavilion (or gazebo area for outside dance), at which time **SCS** will assume responsibility for the child. **SCS** relinquishes responsibility for the child at the point of check-out when they have exited the building (or gazebo area for outside dance) with their parent/guardian from the **SCS** Dance. **SCS** will remain on-site inside the dance area until all children are picked up from the dance inside of the dance pavilion (or gazebo area for outside dance).
